## 5. 2024-906 Department of Homeland Security Grant Program Hazmat Sustainment (HSGP) (B)

**Department:** Gainesville Fire Rescue

**Description:** Request for the Commission to authorize the City Manager or designee to accept a federally-funded subaward from the Department of Homeland Security and enter into a grant agreement with the State of Florida Division of Emergency Management for Gainesville Fire Rescue to purchase hazardous materials program sustainment supplies.

**Fiscal Note:** This is a reimbursement grant not to exceed \$86,995.00 and does not require a match.

**Recommendation:** The City Commission: 1) authorize the City Manager or their designee to accept the award for funding not to exceed \$86,995.00; and 2) enter into the grant agreement and to execute other necessary documents subject to approval by the City Attorney as to form and legality.

6. 2024-910 Meridian Behavioral Healthcare and City of Gainesville Cooperative Agreement for Co-Responder Team (B)

**Department:** Gainesville Police Department

**Description:** Request for the City Commission to approve the City entering into a Cooperative Agreement with Meridian Behavioral Healthcare, Inc. for the Co-Responder Teams that provide clinician/mental health services in an amount not to exceed \$199,504.80. The one-year agreement provides the City will fund the salaries of two (2) mental health clinicians with the option to extend the agreement three times for one year terms each.

**Fiscal Note:** The cost of each clinician's annual salary is \$99,752.37, totaling \$199,504.74 per year for both clinicians. This amount will be rounded up to \$199,504.80 in order to accommodate a 12-month billing cycle of \$16,625.40 per month. Funding is available in the Gainesville Police Department's FY 2025 Operating Budget.

**Recommendation:** The City Commission authorize the City Manager and/or designee to proceed with entering into the Cooperative Agreement with Meridian Behavioral Healthcare, Inc., for a Co-Responder Team and execute the Cooperative Agreement, subject to review and approval by the City Attorney as to form and legality.

7. 2024-911 Use of Federal Law Enforcement Contraband Forfeiture Funds for Purchase of Ballistic Vests for Field Service Technicians (NB)

**Department:** Gainesville Police Department

**Description:** Request for the City Commission to approve the use of Federal Law Enforcement Contraband Forfeiture Funds for the purchase of ballistic vests for the Gainesville Police Department's Field Service Technicians.

**Fiscal Note:** The anticipated cost of the ballistic vests will not exceed \$20,000. The uncommitted balance of the Federal Law Enforcement Contraband Fund as of September 30, 2024 is \$359,373.

**Recommendation:** The City Commission approve the use of the Federal Law Enforcement Contraband Forfeiture Trust Fund totaling \$20,000 for ballistic vests for Police Field Service Technicians.

The total planned private investment is approximately \$19-27 million over the next seven years.

Recommendation: The City Commission direct 1) the City Manager, or designee, to execute the Contract for Purchase and Sale of Real Property regarding Tax Parcel ID #16005-000-000 and ID #16004-000-000 and all related documents subject to approval of form and legality by the City Attorney, or designee, 2) authorize the Mayor, or designee, to execute and deliver, and the City Clerk, or designee, to attest the Special Warranty Deed conveying fee simple title, and 3) authorize and direct pursuant to 270.11, Fla. Stat. that the Special Warranty Deed include a release and discharge of all of the City's oil, gas, and mineral rights on the subject property.

2024-871 Lot #10 - Sixth Purchase and Sale Agreement Amendment (B)
 Department: Office of the City Manager

**Description:** This item represents the sixth amendment to the Lot #10 Purchase and Sale Agreement (PSA). The property owner AMJ Group, Inc. has requested a one-year extension of the terms of the agreement.

Fiscal Note: N/A
