4 **An ordinance of the City of Gainesville, Florida, amending Appendix A,**
5 **Schedule of Fees, Rates and Charges of the Code of Ordinances by revising fees,**
6 **rates and charges for the following: adult performance establishment, escort**
7 **services, and escort licenses; alcoholic beverages; building permit fees;**
8 **cemetery; controlled vehicular parking area decals/permits; fire/rescue; health**
9 **and sanitation; land development code; parks, recreation, and cultural affairs;**
10 **peddlers, solicitors and canvassers; police; registered domestic partnerships;**
11 **right-of-way (public) obstruction permits; right-of-way (public) use by utilities;**
12 **secondhand goods; streets, sidewalks and other public places; taxation; traffic**
13 **and motor vehicles; utilities - solid waste and recyclables; utilities - stormwater**
14 **management; valet operations; and vehicles for hire; providing directions to**
15 **the codifier; providing a severability clause; providing a repealing clause; and**
16 **providing an effective date.**

18 **WHEREAS,** at least ten (10) days' notice has been given once by publication in a
19 newspaper of general circulation notifying the public of this proposed ordinance and of the
20 public hearings in the City Hall Auditorium located on the first floor of City Hall in the City of
21 Gainesville; and

22 **WHEREAS,** public hearings were held pursuant to the published notice described above,
23 at which all interested parties had an opportunity to be, and were, in fact, heard.

24 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF**
25 **GAINESVILLE, FLORIDA:**

26 **Section 1.** Portions of Appendix A of the Code of Ordinances, relating to fees, rates, or
27 charges are amended as set forth in Exhibit "A," attached to this ordinance and incorporated by
28 reference as if fully set forth herein. Except as amended herein, and except as modified by the
29 Gainesville Regional Utilities Authority, the remainder of Appendix A remains in full force and
30 effect.

31 **Section 2.** It is the intention of the City Commission that the provisions of Section 1
32 shall become and be made a part of the Code of Ordinances of the City of Gainesville, Florida,
33 and that the Sections and Paragraphs of this Ordinance may be renumbered or relettered in
34 order to accomplish such intentions.

35 **Section 3.** If any word, phrase, clause, paragraph, section, or provision of this ordinance
36 or the application hereof to any person or circumstance is held invalid or unconstitutional, such
37 finding shall not affect the other provisions or applications of the ordinance which can be given
38 effect without the invalid or unconstitutional provisions or application, and to this end the
39 provisions of this ordinance are declared severable.

40 **Section 4.** All ordinances, or parts of ordinances, in conflict herewith are to the extent
41 of such conflict hereby repealed on the effective date of this ordinance.

42 **Section 5.** This ordinance shall take effect immediately upon adoption; provided
43 however the fees, rates, and charges set forth herein shall be applicable to fees, rates, and
44 charges which are due and payable after 12:01 AM on October 1, 2025, provided however, new
45 fees, rates, and charges are not applicable to reservations of parks, recreational, or cultural
46 facilities, if the reservation was booked prior to the effective date of this ordinance, in which
47 case the City will charge the fees, rates, and charges in place at the time the reservation was
48 booked.
