

Business Impact Estimate

Ordinance No. 2024-315

An ordinance of the City of Gainesville, Florida, amending the Land Development Code (Chapter 30 of the City of Gainesville Code of Ordinances) related to public participation and notice and providing definitions for legislative and quasi-judicial decisions, as more specifically described in this ordinance; providing directions to the codifier; providing a severability clause; providing a repealing clause; and providing an effective date.

This Business Impact Estimate is provided in accordance with section 166.041(4), Florida Statutes.  - c. Sections 190.005 and 190.046, Florida Statutes, regarding community development districts;
 - d. Section 553.73, Florida Statutes, relating to the Florida Building Code; or
 - e. Section 633.202, Florida Statutes, relating to the Florida Fire Prevention Code.

In accordance with the provisions of controlling law, even notwithstanding the fact that an exemption noted above may apply, the City hereby publishes the following information:

1. Summary of the proposed ordinance (must include a statement of the public purpose, such as serving the public health, safety, morals and welfare):

This ordinance will amend the City of Gainesville's Land Development Code to add definitions for quasi-judicial and legislative items and revise the newspaper ad requirement to allow for online posting of required newspaper ads for public hearings. These changes are intended to improve public notification of public hearings, and overall understanding of the public hearing process.

2. An estimate of the direct economic impact of the proposed ordinance on private, for-profit businesses in the City, if any:

- (a) An estimate of direct compliance costs that businesses may reasonably incur;
- (b) Any new charge or fee imposed by the proposed ordinance or for which businesses will be financially responsible; and
- (c) An estimate of the City's regulatory costs, including estimated revenues from any new charges or fees to cover such costs.

This ordinance will not have any direct economic impacts on private, for-profit businesses in the City. There are no new direct compliance costs that businesses will incur, no new charges or fees imposed by this ordinance, and no regulatory costs or revenues since no new fees or charges are proposed.

3. Good faith estimate of the number of businesses likely to be impacted by the proposed ordinance:

This ordinance will not have any direct economic impacts on private, for-profit businesses in the City.

The proposed ordinance is a generally-applicable ordinance that does not affect only businesses and applies to all persons similarly situated (individuals as well as businesses).
