Motion: 1) Increase densities within the U-4 to DT transect zoning districts consistent with the Commissioner's proposal contained in the added backup: 2) Amend the Historic District compatibility criteria to provide flexibility for projects providing the mandatory IZ units built onsite (vs. fee-in-lieu) consistent with the Commissioner's proposal contained in the added backup including waiving the 6 unit per building limit for said projects; 3) Hold additional public workshops and include the AHAC in the public outreach/information effort; 4) Staff to evaluate approach for accounting for additional mandatory fees like valet garbage charged to residents; and 5) Staff to work towards goal of having a second reading of IZ ordinance before the end of the year.
