
**south of** Gainesville City Limits & SW 47th Place,

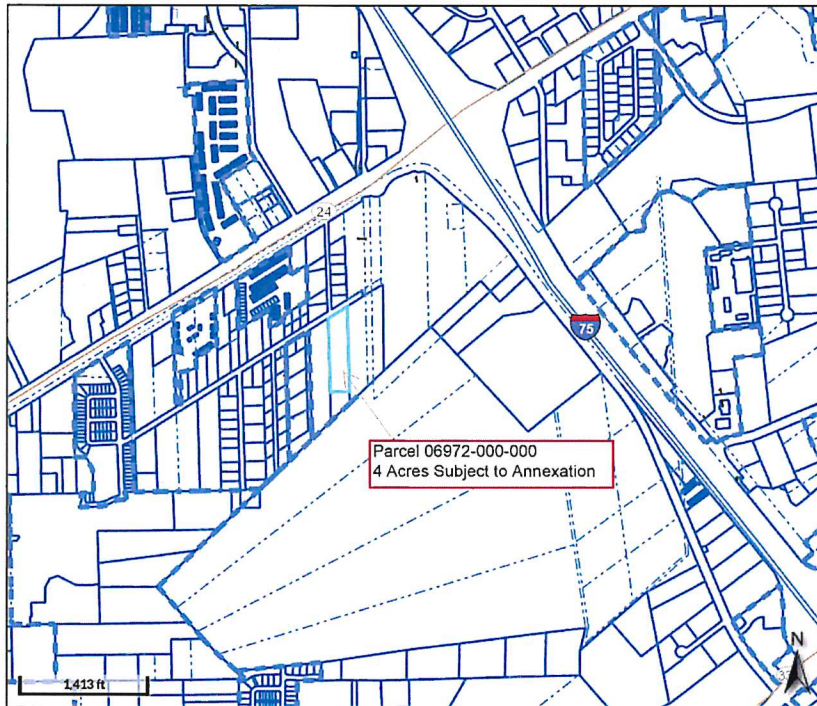
