AD. COMMISSION COMMENT

Commissioner Book - Is interested in inviting UF to the March 9th GPC meeting to discuss options for expanded UF contributions to the community. Kudos to the Director of Housing, Corey Harris for an awesome Heirs Forum.

Commissioner Willits - As we go forward, I want to talk a little bit about the idea of this Commission and how it's always run, or our roles as Commissioners, and how we interact with staff, Charter Officers. As I was running for office, and since I've come into office, I had multiple community members tell me rather not to treat our Charters like the well-paid and qualified people they are, but instead to second-guess everything they say because they're going to lead you around by the nose. You're the newbie. They're going to tell you what they want. I'm not much of a cynic, I really am not. I'm skeptical, but not a cynic, and so that kind of – that thought competes with the thought - I think about that when there are suggestions that this a part-time role and we should just rely on our, you know, highly-qualified staff, highly-qualified Charters because there is still an amazing amount of – it's not just that we get the expert opinion of somebody and we accept it where there's discretion. We feel out the community, we listen to our neighbors, we answer e-mails, we read reports. We read reports from non-staff, stuff that comes to us from citizens. We go to meetings. We listen. When you step out of your front door, a neighbor greets you and takes up ten minutes of

your time while you're trying to head to this meeting, just this morning. I enjoy getting to learn what people's concerns are. So that's one little portion that I just wanted to put that out there. But I want to come back to something I said to make sure that it is clear amongst all my colleagues. I announced to run for this office in May of last year. I was nearly elected in August, but for less than one percentage point avoiding a runoff, I won in the first week of November. The previous Commission decided first to pass a pay raise, I believe the next week, in November, with a second reading in December. I arrived to this Commission on January 5th. I had my last day as my full-time position at University of Florida on February 3rd. And then on February 6th I started my part-time position. It is not my job to respond to every community member who speaks at these meetings. so I will try not to. But what was suggested tonight was nearly nefarious. This idea that I knew before I ran that the salaries were going to increase is a salacious accusation. So, I needed to say, no, but it was the wrong time. But I want to talk to you tonight – because that was a salacious accusation. I can't let it stand out there in the public because I did not clarify myself. When I arrived to this Commission on January 5th, I had expectations of what the next budget year salary would be. So, I wanted to say that because it was, in essence, if not fully articulated, any astute observer would have heard a very large accusation and I had to say something about it tonight, even though it is 9:30.

Commissioner Chestnut - Along that same line, Commissioner, something very disturbing occurred with the reporting by the Gainesville Sun in reporting our action plan regarding GRU. In the February 28th paper, the reporter stated that, referring to Chestnut, "if that doesn't work, she added, the City should entertain the idea of selling off GRU". That is total misinformation. At no time, did I make such a statement. I reviewed the recording, and at no time did I discuss selling GRU. On February 28th, I brought the misinformation to the attention of the reporter who printed a correction on March 1st that stated, "though Commissioner Chestnut brought up the idea, she did not express support for it". Well, that statement is false. Blatantly false, and at no time did I bring up the idea of selling GRU. I think the record needs to be corrected. I'd like this spread in the minutes, so that if I ever have to use this in the future, I will have the exact quotation. But that is just blatantly false information.

Commissioner Eastman - Would like to have a joint meeting with the City Commission and City Plan Board.

Moved by Commissioner Eastman

Motion: Direct staff to schedule a Joint Meeting with the City Commission and City Plan Board before April meeting.

Mayor Ward -

There are a few things I want to talk about. I'll try to be brief here. I've been here nearly 13 hours already. Earlier, I read a proclamation about News Literacy Day and we talked about the importance in that proclamation, the importance of fighting misinformation. We ride a very difficult line here of being less than civil sometimes, of feeling like we're being less than civil if we respond to misinformation sometimes, or -- in the case of the "Gainesville Sun" headline, of starting a fight with people who sell ink -- or buy ink by the barrel. As the saying goes, we don't want to do that. But it's important to set the record straight and when someone either writes something that is incorrect or says something incorrect, regardless of their intent. If you don't raise your hand and say wow, that's not accurate, then it becomes accurate eventually. I watched Mayor Poe consistently do the very Christian thing and turn the other cheek, a lot in cases where I know that it was really hard and hurt to do that. I will advise those of you who are new and tell everybody that you do have to stand up for yourself. We do and that I will support you in setting the record straight because it matters. No matter who is up here, we need to be represented accurately and if the story keeps getting told over and over and over that is wrong, it becomes the truth as far as the public is concerned. It is important to make sure that we do stand against misinformation. Usually, that starts with a simple hey, maybe you misunderstood me. Now I know that by doing this I am likely to hear back about it at some point in the not-too-distant future. I think we need to set a standard for what's okay and what's not. I'm not doing this in any kind of pushing match, but it's important for the truth to actually be the truth and to call it out when it is not. Having said that again, I know I've lit a fire for future meetings, but it matters and particularly in the wake of that proclamation that I read this evening.

I think it's important to point that out a procedural thing that is important to note this evening. I spoke with Ms. Anderson a couple of days ago. She is enjoying and looking forward to continuing to be our Interim Auditor but is not interested in being the permanent Auditor. We will need to engage the process to start a full-on search for that position. I just wanted to make you all aware of that at the first opportunity here. She and I talked early on about on this being a test phase to see this job is something she wanted to do. It's an interesting time to be going through that test. The other five of you are stuck with us. I want to thank you all for your efforts today. It has been a very long meeting, but we did get some work done. There are going to be a lot more days like this. We have a lot of work ahead of us and I trust that we will get things done.
