Dear **John Alexander**,

I am pleased to inform you that **Gainesville Police Activities League** has been selected to participate in National PAL's FY22 (2023) Mentoring Program, funded through the U.S. Department of Justice, Office of Justice Programs, Office of Juvenile Justice and Delinquency Prevention (OJJDP) [Award number 15PJDP-22-GG-01747-MENT]. The National PAL Mentoring Initiative will implement youth mentoring programs that strengthen and expand mentoring services to at-risk/high-risk youth populations, through PAL Chapters.

Project Goals: Target youth include those who a) live in communities with high community risk factors including poverty, unemployment, violent crime, and drug/gang involvement; b) attend schools that have a high percentage of students eligible for free and reduced-price meals and have high rates of absenteeism; c) are American Indian or Alaska Native; d) have one or more parents in the military; and/or e) live in rural communities. Mentors and mentees will participate in positive mentoring activities through PAL Chapters, providing greater opportunities for individual/group mentoring and academic achievement. The performance measurements for this initiative will include increasing the participating youth's view of law enforcement, understanding the dangers of drug and gang involvement, and increasing their perception of social support.

Your organization will receive a sub-award to serve **16** youth in the amount of **\$14,400.00** to be used for direct operating expenses associated with the implementation of the National PAL Mentoring program in partnership with National PAL. All funds must be appropriately expended or obligated between **March 1, 2023, and March 1, 2024**.

There will be a **MANDATORY LOA and INTRODUCTION MEETING Wednesday, March 1st at 2 pm est.** This is a required meeting so please make sure you have a representative on this call.

Reminders

There will be a spend-down requirement for each chapter, if a chapter does not meet the requirement, it is highly possible that your award amount will be reduced.

It is also recommended that chapters consider utilizing funds towards the utilization of staff opportunities.

Each grant recipient program must obtain and be insured.

Any chapter that is awarded less than \$18,900 will be responsible for attending the grant training but can do so virtually, if unable to travel to Las Vegas due to financial constraints. All chapters will still be responsible for attending the Youth Summit with a 1 mentor to 2 mentee ratio. We will provide a virtual link for the grant training and attendance will be taken. Any chapter awarded over \$18,900 will be required to attend the grant training on April 11th **in person**.
