Title: 2023-244 Bid Award for Pavement Management Continuing Services (B)

Department: Public Works

Description: Bid award for pavement management (preservation and surfacing) agreements.

Fiscal Note: Funds for services is budgeted, as needed, in operating and capital project accounts.

Explanation: Invitation to Bid #PWDA-230027-DH for Pavement Management (Preservation & Surfacing) Continuing Services was issued on December 19, 2022, and opened on January 31, 2023. Push button continuing services agreements minimize the use of staff resources for the procurement of services and provide an option to mobilize quickly if a project schedule requires expedited delivery.

There were five responsive, responsible bidders, Asphalt Paving Systems Inc. (APS) (Zephyrhills, FL), Pavement Technology, Inc. (PTI) (Westlake, OH), Preferred Materials, Inc (PMI) (Jacksonville, FL), V.E. Whitehurst & Sons, Inc. (VEW) (Williston, FL) and Watson Construction Company LLC (WCC) (Newberry, FL).

The scope of the bid is for push button (on-demand) construction services related to pavement management including milling, asphalt surfacing, asphalt surface treating (crack seal, chip seal, scrub seal, micro-surfacing, cape seal, and asphalt rejuvenation), roadway base work, roadway concrete work and pavement marking services. One bid was received for Base Work, Milling & Concrete Work (WCC), two bids for Crack Seal (APS and WCC), two bids for Asphalt Placement (VEW and WCC), two bids for Asphalt Pick-up (PMI and WCC), one bid for Chip Seal, Micro-surfacing, & Scrub Seal (APS), one bid for Asphalt Rejuvenation (PTI) and two bids for Pavement Markings (APS and WCC). Staff recommends awarding agreements to each vendor; vendors will be selected based on pricing and then availability.

Work orders for projects will be issued on an individual basis as needed.

Recommendation: The City Commission: 1) award Bid #PWDA-230027 to Asphalt Paving Systems Inc., Pavement Technology, Inc., Preferred Materials, Inc., V.E. Whitehurst & Sons, Inc. and Watson Construction Company LLC for Pavement Management Continuing Services and 2) authorize the City Manager or designee to negotiate and enter into an agreement with each vendor in the amount of \$4 million per fiscal year through FY27, subject to the approval by the City Attorney or designee as to form and legality.
