11	WHEREAS, the Municipal Home Rule Powers Act, Chapter 166, Florida Statutes, secures for
12	municipalities the broad exercise of home rule powers granted by Article VIII, Section 2 of the
13	Florida Constitution, including the exercise of any power for municipal purposes not expressly
14	prohibited by law; and
15	WHEREAS, Section 163.3167, Florida Statutes, requires the City of Gainesville to maintain a
16	Comprehensive Plan to guide the future development and growth of the city; and
17	WHEREAS, Section 163.3177(6), Florida Statutes, requires the City of Gainesville
18	Comprehensive Plan to include a Future Land Use Element with a Future Land Use Map that
19	designates the future general distribution, location, and extent of the uses of land for
20	residential, commercial, industry, agriculture, recreation, conservation, education, public
21	facilities, and other categories of the public and private uses of land, with the goals of
22	protecting natural and historic resources, providing for the compatibility of adjacent land uses,
23	and discouraging the proliferation of urban sprawl; and
24	WHEREAS, the City of Gainesville is required by Section 163.3202, Florida Statutes, to adopt or
25	amend and enforce land development regulations that are consistent with and implement the
26	Comprehensive Plan and that are combined and compiled into a single land development code
27	for the city; and

WHEREAS, the City of Gainesville Land Development Code (Chapter 30 of the City of Gainesville 28 29 Code of Ordinances) establishes zoning districts to implement the Comprehensive Plan and 30 land development regulations on specific classifications of land within the city; and 31 WHEREAS, this ordinance, which was noticed as required by law, will amend the Zoning Map 32 Atlas by rezoning the property that is the subject of this ordinance; and WHEREAS, the City Plan Board, which acts pursuant to the authority granted in Section 4.02 of 33 the Charter Laws of the City of Gainesville and which acts as the Local Planning Agency 34 pursuant to Section 163.3174, Florida Statutes, held a public hearing on January 26, 2023, to 35 consider this application and provide a recommendation to the City Commission; and 36 WHEREAS, at least ten days' notice has been given once by publication in a newspaper of general 37 circulation notifying the public of this proposed ordinance and public hearings held by the City 38 Commission; and 39 WHEREAS, the public hearings were held pursuant to the notice described above at which 40 41 hearings the parties in interest and all others had an opportunity to be and were, in fact, heard; and 42 WHEREAS, the City Commission finds that the rezoning of the subject property will be 43 consistent with the City of Gainesville Comprehensive Plan when the amendment to the 44 Comprehensive Plan adopted by Ordinance No. 2023-77 becomes effective as provided 45 therein. 46 47 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA: 48 **SECTION 1.** The Zoning Map Atlas of the City of Gainesville is amended by rezoning the 49




