
south of Gainesville City Limits & SW 47th Place,

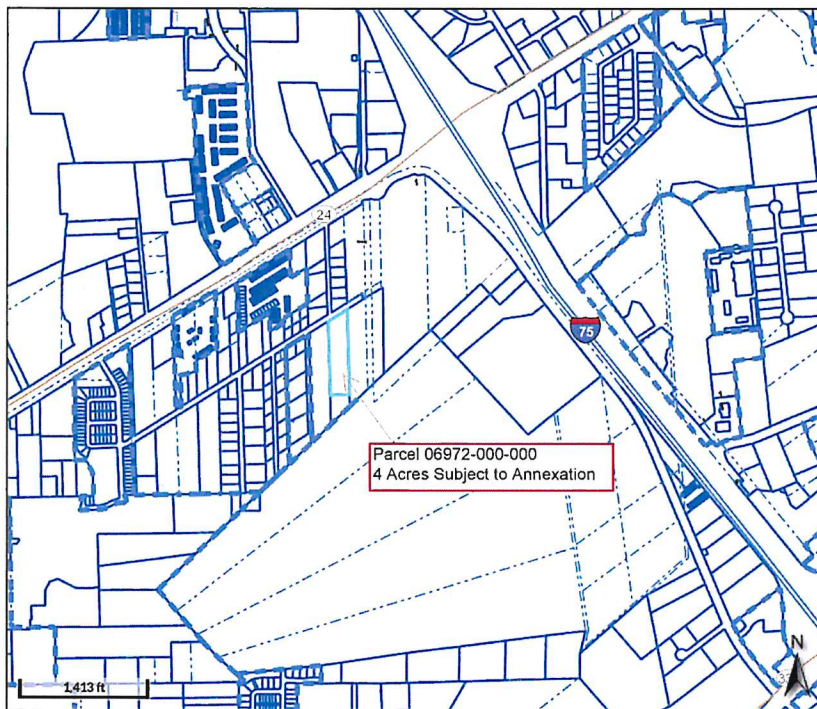
