## CONSTRUCTION OF NW 53rd AVENUE SIDEWALK

(CONTRACT FOR CITYWIDE SIDEWALK, TRAIL, & MINOR ROADWAY CONSTRUCTION)

**THIS TASK ASSIGNMENT** is entered into on this \_\_\_\_ day of \_\_\_, 2023 between the CITY OF GAINESVILLE, a Florida municipal corporation ("CITY"), and BLACKWATER CONSTRUCTION SERVICES, LLC, a Florida limited liability company ("CONTRACTOR"), and describes services to be performed in accordance with the Contract for Citywide Sidewalk, Trail and Minor Roadway Construction, dated August 10<sup>th</sup>, 2020.

- 1. SCOPE OF WORK AND ORDER OF PRECEDENCE. CONTRACTOR shall perform the work described in the following contract documents, whether attached or incorporated by reference. In the event that there is any conflict between the terms and conditions contained in this Task Assignment and other Contract Documents referenced herein, the order of precedence shall be as follows:
  - a) This Task Assignment.
  - **b)** Contract for City Sidewalk, Trail and Minor Roadway Construction, dated August 10<sup>th</sup>, 2020.
  - **c)** CONTRACTOR's proposal titled "NW 53<sup>rd</sup> Ave Sidewalk Project Proposal for Construction," dated April 27, 2023, attached and incorporated as Exhibit A.
- **2. SCOPE.** This project is located on the west side of NW 53<sup>rd</sup> Ave, and includes construction of new sidewalk connection. The project includes the construction of sidewalk and associated drainage improvements in accordance with the plans provided by the CITY, attached and incorporated as Exhibit B.
- **3. PROJECT SCHEDULE.** Time is of the essence for this Task Assignment, and all work shall be completed by December 12, 2023.
- **4. MEETINGS AND PROJECT MANAGEMENT.** CONTRACTOR will coordinate implementation of plantings with CITY staff.
- **5. SPECIFIC CITY RESPONSIBILITIES.** The CITY shall be responsible for responding to requests for additional information by the CONTRACTOR. The CITY will provide for oversight of the project's implementation as described in Exhibit A.
- **6. COMPENSATION.** The total lump sum cost for the project is Three-Hundred and Twenty-Eight Thousand, Two-Hundred and Thirty-Seven Dollars (\$328,237.00), as detailed in Exhibit A.
- **7. SPECIAL PROVISIONS.** The CITY's Project Manager will be Bermann Mesadieu (352-756-1068) and the CONTRACTOR's Project Manager will be Derek Dykes (352-644-3453).
- **8. SECURITY.** No security is provided or required for this project.
