

RESOLUTION NO. 2023-1069

A Resolution of the City Commission of the City of Gainesville, Florida; relating to its general government budget for the fiscal year beginning October 1, 2022 and ending September 30, 2023; amending Resolution No. 2022-265, as amended by Resolution No. 2022-622, Resolution No. 2022-750, Resolution No. 2023-140, Resolution No. 2023-487, Resolution No. 2023-668 and Resolution No. 2023-775 by making certain adjustments to the General Government Financial and Operating Plan Budget; and providing an immediate effective date.

WHEREAS, on September 22, 2022, the City Commission of the City of Gainesville, Florida, adopted Resolution No. 2022-265 for the purpose of approving and adopting a final budget for Fiscal Year 2023;

WHEREAS, on October 20, 2022, the City Commission of the City of Gainesville, Florida, adopted Resolution No. 2022-622 amending the General Government Financial and Operating Plan Budget as set forth therein;

WHEREAS, on December 1, 2022, the City Commission of the City of Gainesville, Florida, adopted Resolution No. 2022-750 amending the General Government Financial and Operating Plan Budget as set forth therein;

WHEREAS, on March 2, 2023, the City Commission of the City of Gainesville, Florida, adopted Resolution No. 2023-140 amending the General Government Financial and Operating Plan Budget as set forth therein;

WHEREAS, on June 1, 2023, the City Commission of the City of Gainesville, Florida, adopted Resolution No. 2023-487 amending the General Government Financial and Operating Plan Budget as set forth therein;

1 **WHEREAS**, on July 20, 2023, the City Commission of the City of Gainesville, Florida,
2 adopted Resolution No. 2023-668 amending the General Government Financial and Operating
3 Plan Budget as set forth therein;

4 **WHEREAS**, on September 7, 2023, the City Commission of the City of Gainesville,
5 Florida, adopted Resolution No. 2023-775 amending the General Government Financial and
6 Operating Plan Budget as set forth therein;

7 **WHEREAS**, it is necessary to make certain amendments to the General Government
8 Financial and Operating Plan Budget in order to fund their activities;

9 **WHEREAS**, the City Commission desires now to amend the General Government
10 Financial and Operating Plan Budget as fully set forth below.

11 **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE**
12 **CITY OF GAINESVILLE, FLORIDA:**

13 **Section 1.** The General Government Financial and Operating Plan Budget for Fiscal Year
14 2023 is hereby amended as set forth in Attachment “A” which is attached hereto and made part
15 hereof as if set forth in full.

16 **Section 2.** Except as herein above modified and amended, the General Government
17 Financial and Operating Plan Budget for Fiscal Year 2023 as adopted by Resolution No. 2022-265
18 and amended by Resolution No. 2022-622, Resolution No. 2022-750, Resolution No. 2023-140,
19 Resolution No. 2023-487, Resolution No. 2023-668 and Resolution No. 2023-775 shall continue
20 and remain in full effect.

21 **Section 3.** This Resolution shall become effective immediately upon adoption.
