



PROJECT DISCUSSIONS

2024-523C

Oakview Apartments Phase II

Amount: \$1,748,000

(\$1,080,094.27 Revenue Replacement ARPA category and \$704,905.73 in the Core ARPA category)

- Affordable housing project to create 51 multi-family rental units targeting the elderly demographic
- Developer has requested a forgivable loan vs. a grant (as advertised in the Notice of Funding Availability) and staff has worked with City Attorney's Office to review options available
- Developer has not finalized the project budget from other partners (Alachua County)
 - Developer does not want to sign City subrecipient agreement without first obtaining a formal commitment from Alachua County for Infrastructure Surtax funding for the same project
- Staff recommends \$1,080,094.27 for a Government Services Set-Aside for FY 2025 in the Revenue Replacement category
- The remaining \$704,905.73 in the Core ARPA category Remaining funding can be allocated to other projects such as Affordable Housing, Homeless Support Services or Gun Violence programming (prevention, suppression, enforcement).
 - Staff will provide a recommendation for projects on September 12, 2024.

Aid to Nonprofit Organizations

Amount: \$6,961,322.19 (Core ARPA category)

Estimated Remaining: \$757,836.65 (as of July 15, 2024)

- Nonprofit Organizations were given until May 31, 2024 to submit final invoice to allow for administrative processing time before the December 31, 2024 deadline
 - Current estimate: \$6,203,485.54 or 89.1% of the project budget has been spent down
- Invoices are still being processed; all final invoices are reviewed to ensure final documentation is complete and meets requirements of the subrecipient agreement
- Remaining funding can be allocated to other projects such as Affordable Housing, Homeless Support Services or Gun Violence programming (prevention, suppression, enforcement).
 - Staff will provide a recommendation for projects on September 12, 2024.

Deadline to allocate funding: December 31, 2024

Administrative - General Consultant

Amount: \$1,215,330 (Core ARPA category)

Estimate through December 2026: \$999,888 (as of July 15, 2024)

- July 31, 2024 U.S. Treasury report requires a projection of administrative expenses through December 31, 2026
 - City Administrative expense projection updated for the April 30, 2024 US Treasury report and remain current
- GSG estimates a reduction of \$215,442 to their contract based on actual hours billed and projections through December 2026
- Remaining funding can be allocated to other projects such as Affordable Housing, Homeless Support Services or Gun Violence programming (prevention, suppression, enforcement).
 - Staff will provide a recommendation for projects on September 12, 2024.

Deadline to allocate funding: December 31, 2024

Recommendation

The City Commission:

- Decrease the budget of Administrative General Consultant GSG project from \$1,215,330 to \$999,888 and move the remaining funding of \$215,442 to the Core ARPA unallocated budget line currently budgeted at \$32,109.29.
- Decrease the budget of the completed Cultural Arts Center Feasibility Study project from \$197,287.50 to \$123,254.07 and move the remaining funding of \$74,033.43 to the ARPA Revenue Replacement unallocated budget line currently budgeted at \$32,109.29.
- De-obligate funding for the Oakview Apartments Phase II project totaling \$1,785,000.00 comprised of \$1,080,094.27 in the ARPA Revenue Replacement category and \$704,905.73 in the Core ARPA category and move the funding to the unallocated budget line for each category.
- Allocate \$1,186,236.99 to a new project titled Government Services Set-Aside for FY25 in the Revenue Replacement category.
