Advocacy, Communications, Tracking and Reporting

During interim committee weeks and the legislative session, GT will provide weekly written reports as well as a Legislative Session Summary Report at the end of session. These reports will include information pertaining to any legislative activity of interest to the City as well as the impact of any approved legislation. GT also provides a daily newsletter, Sunshine State Insights (SSI), to provide information relative to Florida politics, cabinet and executive agencies, and the Legislature.

Greenberg Traurig will identify and monitor all issues that may impact the interests of the City of Gainesville throughout this engagement, with a particular focus on issues of local and regional importance such as transportation and road redevelopment, pedestrian safety, affordable housing, homelessness, annexation, cybersecurity, home rule, energy, higher education, historic preservation and other local priorities as defined by the client. A final legislative report, highlighting local legislative and appropriations priorities as well as passed legislation of general interest, will be provided to you within 21 days of the legislature's Sine Die. Please note further updates will also be provided as the governor vetoes or signs legislation or budget appropriations into law.

Off Session

Each year, the Florida Legislature develops interim reports and files legislation relating to home rule authority, land use and zoning issues, growth management, city and municipal planning, water resources, economic development initiatives homelessness, mental health and environmental initiatives which can impact local governments. Additionally, there may also be state policy and regulatory actions, and state grant funding opportunities of interest to the City during the period of months following a legislative

session. GT will closely monitor, provide information and guidance on anything requiring action by the City during that time.

Additionally, GT will work closely with the City in developing their legislative advocacy agenda for the following session, including assisting with local legislative delegation meetings and other meetings of local relevance. 


